A few years ago, our Rotary Board set the ambitious goal of increasing the share of female members to 30 percent by 2023. We have less than a year to go, but I believe we can meet and exceed this target.

TRUSTEE CHAIR'S MESSAGE Two sides of the same coin

During my travels, Rotary often comes up in conversation. Most people associate us with local projects and fundraisers — which is great — but few know what a global force Rotary is. It's easier to understand this aspect of Rotary through an example, such as how Rotary responded to the devastating bushfires in Australia in late 2019 and early 2020.

The result of extreme drought, global warming, and adverse weather conditions, the fires caused catastrophic damage. The need for help was obvious and substantial.

No stranger to forest fires themselves, Canadian Rotarians knew the best way to help was through The Rotary Foundation. They were soon joined by Rotary clubs and districts in other countries and Taiwan, resulting in three Foundation global grants totaling \$280,000 to support the economic recovery of farmers affected by these fires.

One farmer wrote a letter of thanks on behalf of the remote communities we helped, saying they "were in disbelief that Rotary clubs from other countries would step up and help our relatively small farming region" and adding that "they were very grateful and honored to be considered worthy of such aid." Friends, this is the kind of impact your Foundation has every single day around the world and why it deserves the support of all Rotary members. The most significant projects done in Rotary's name are those accomplished through The Rotary Foundation. The list goes on and on. Think of the impact of our polio eradication efforts, our peace education programs, and our Programs of Scale grants. All these efforts to make the world a better place emanate from our Foundation.

The Foundation also impacts our club experience, membership, partnerships, and so much more. The more visibility and impact we have through Foundation projects, the more people want to be part of what we are doing as partners or as members. Everybody wins.

To me, Rotary and its Foundation are inseparable — you can't have one without the other. They are two sides of the same coin. I love the friendship and fellowship and projects I experience as a member of the Rotary Club of Sandringham, Australia, but I am also thrilled to be part of a global movement that is changing the lives of countless people through The Rotary Foundation. Remember that other side of the Rotary coin and support your Foundation. By doing so, you will also be supporting your fellow members who are bringing to life the projects our world truly needs.

- 3. Use my professional skills through Rotary to: mentor young people, help those with special needs, and improve people's quality of life in my community and in the world
- 4. Avoid behavior that reflects adversely on Rotary or other Rotarians
- 5. Help maintain a harassment-free environment in Rotary meetings, events, and activities, report any suspected harassment, and help ensure non-retaliation to those individuals that report harassment.

- The Rotary Club of Network for Empowering Women, which was featured in the North American Rotary Magazine;
- The Kaleidoscope Rotaract Club, to serve those with Autism and their families;
- The Rotaract eClub for the Environment the first ever cause-based, international, Rotaract eClub focusing on the environment, which was mention by Rotary CEO John Hugo in his closing remarks at the 2021 Rotary International Convention;
- The Rotary Club of Global Travelers, which was featured in the North American Rotary Magazine; and
- The Minnesota Pride Rotary Club.



Guest of Honor

Tom was one of only 20 North American Rotary leaders selected by Rotary International Past President Mark Maloney and Rotary International Membership Staff to participate in a *New Club Development Summit* and was subsequently named as a *Zone 29 Innovative Club Advocate*. Tom is also one of only 500 Rotarians in the world to be named to <u>The Membership Society for New Member</u> <u>Sponsors</u> for bringing in more than 50 active members into his club, which puts him at the Gold Level of the Society.

Tom now inspires others around the world and helps them form their own new and innovative Rotary clubs. He speaks regularly on the topic of membership at Rotary club, district, multi-district, zone and international events. He spoke at this year's *Rotary International Assembly* and for the past few years has led and been a speaker on breakout session panels and workshops at *Rotary International Conventions*. He is on the PETS Alliance's list of "Popular

Speakers." Next month he will speak at the Presidential Peace Conference and on three breakout sessions at the International Convention.

The North American *Rotary* magazine and other Rotary regional magazines have written about Tom. Tom's tips for attracting and retaining members and some of the clubs he has started have also been featured as part of cover stories. Rotary regional magazines have published articles by him. Tom's articles have also appeared in Rotary's blog *Rotary Voices*.

Tom was the winner of 2021 "Zones 28



and 32 Individual Membership Innovation Award," for promoting new cause-based clubs throughout the world.

Tom served as General Chair of the 2021 Zones 25B and 29 Rotary Institute and was a 2022 Rotary International Assembly Training Leader.

New directors and trustees take office

The RI Board of Directors has 19 members: the RI president, the president-elect, and 17 directors, who were nominated by their zones and elected at the Rotary International Convention. The Board manages Rotary International affairs and funds in accordance with the RI Constitution and Bylaws. Eight new directors and the president-elect took office on 1 July.

The Trustees of The Rotary Foundation manage the business of the Foundation, the charitable arm of Rotary that funds service activities. The RI president-elect nominates the trustees, who are elected by the RI Board to four-year terms. The trustee chair-elect and two new trustees took office on 1 July.

DIRECTORS

R. Gordon R. McInally

President-elect, 2022-23; Rotary Club of South Queensferry, Scotland



R. Gordon R. McInally is president-elect of Rotary International. He was educated at the Royal High School in Edinburgh and at the University of Dundee, where he earned his graduate degree in dental

surgery. He operated his own dental practice in Edinburgh until 2016. McInally was chair of the East of Scotland branch of the British Paedodontic Society and has held various academic positions. He has also served as a presbytery elder, chair of the Queensferry parish congregational board, and commissioner to the general assembly of the Church of Scotland.

McInally joined Rotary in 1984 at age 26. A member of the Rotary Club of South Queensferry, he has served as president and vice president of Rotary International in Great Britain and Ireland (RIBI). He has also served RI as a director and on several committees, including as an adviser to the 2022 Houston Convention Committee and as chair of the Operations Review Committee.

McInally says he looks forward to working with members to build new Rotary clubs and groups. "My vision is that Rotary should exist everywhere in a style to suit everyone who has the desire to be part of us and to help us

Alberto Cecchini Rotary Club of Roma Nord-Est, Italy



Alberto Cecchini is the sole administrator and technical director of Idroesse Engineering, one of the oldest firms of its kind in Italy. He earned his bachelor's and master's degrees in civil engineering at

Sapienza University of Rome in 1988. He also served as a partner, board member, and technical director of 3TI Progetti Italia, an engineering firm with offices in cities including Rome and Milan; Muscat, Oman; and Hong Kong. Among the many projects he has led or designed are the rehabilitation of a water and sanitation system in Kenya, the construction of a new military air base in Oman, and the rebuilding of panoramic Provincial Road 28 in Sicily.

Cecchini's first experience with Rotary was in 1988, when he became a founding member of the Rotaract Club of Anzio-Nettuno. He joined his first Rotary club in 1994. Cecchini has served RI at the zone and international levels, including as a committee member, Rotary public image coordinator, training leader, regional coordinator and adviser, governors-elect training seminar facilitator, and International Assembly speaker. Drawing on his experience in Rotary's youth programs, he served as chair and vice chair of the Rotaract-Interact Committee and chaired the Rotaract Preconvention in Sydney in 2014. In addition,

he has served as the primary RI representative to numerous Rome-based organizations, including the Food and Agriculture Organization of the United Nations, the International Fund for Agricultural Development, and the World Food Programme. He is also the RI representative to the Holy See in Vatican City.

Cecchini conceived and organized a polio eradication fundraiser at the Colosseum in Rome in June 2018 that featured actors from the film Gladiator, including Russell Crowe and Connie Nielsen, as well as a projection of the movie within the Colosseum with a live orchestra. The event raised \$500,000. Cecchini has also volunteered during a National Immunization Day in Delhi, India, and has delivered bed nets in Guinea Bissau.

Cecchini divides his time between Padua and Rome. In his spare time, he enjoys exercising, traveling, golf, and reading.

Cecchini has received the Service Above Self Award and The Rotary Foundation Citation for Meritorious Service. He supports the Foundation as a multiple Paul Harris Fellow and Benefactor.

Patrick D. Chisanga Rotary Club of Nkwazi, Zambia



Patrick D. Chisanga, a chartered governance professional, is a fellow of the Chartered Governance Institute (UK) from the London School of Accountancy and a fellow of the Institute of Directors of Zambia. He has advised the World Bank on corporate governance and has served as president of the Institute of Directors of Zambia and the African Corporate Governance Network. Later, while serving as RI president's representative at a district event in Bremerhaven, Germany, he lent his networking skills to help start a project to improve infrastructure in Zambian schools that later received several Rotary Foundation grants.

Chisanga has served Rotary International on several committees, including the Membership Committee and the Reach Out to Africa Committee, and as a training leader and Rotary Institute chair. He has also chaired regional Rotary organizations, including the Governors' Council of Southern and Eastern Africa.

Chisanga has received the Service Above Self Award and The Rotary Foundation Citation for Meritorious Service. He and his partner, Petronella, are Major Donors.

University of Engineering and Technology, Kidwai was later awarded a research fellowship in conservation in Mostar, Bosnia-Herzegovina, by the Aga Khan Program for Islamic Architecture at Harvard University. A specialist in socially responsive architecture, Kidwai has developed master plans for urban housing projects as well as large urban development and city planning projects. Kidwai, who joined Rotaract in 1980, is the first Rotary director from Pakistan. In 1986, departing from Karachi on a Rotary Group Study Exchange trip to Canada, Kidwai survived a violent attack during the hijacking of Pan Am Flight 73. "I pledged that, if given another chance to live, I would dedicate my life to the betterment of humanity," he says. "This was the moment that influenced me to join Rotary."

He has been involved in supporting Afghan refugees in Pakistan, co-chairing an initiative that has assisted more than 50,000 Afghan refugees, and working on projects that fight poverty and hunger while promoting the education and empowerment of Afghan girls and women. Kidwai says he would like to see Rotary become the most influential service organization in the region.

Kidwai has received the Service Above Self Award, The Rotary Foundation Distinguished Service Award, and The Rotary Foundation Citation for Meritorious Service.

Patricia Merryweather-Arges is the executive director of Project Patient Care, a nonprofit that brings together patients, families, and caregivers to improve health care. In that role, she has led

nationwide patient and family engagement initiatives with 140,000 clinicians as well as an 18-month project to bring patient concerns into diagnostic research. She helped develop a guide to elective services during the COVID-19 pandemic that was highlighted in the *New York Times* and more than a dozen health journals.

Barry Rassin is a director and former president of Doctors Hospital Health System in Nassau, Bahamas, where he retired after a 38-year career. He was the first fellow of the American College of

Healthcare Executives in the Bahamas and was honored with the National Award of Health Hero by the Bahamas Ministry of Health and the Pan American Health Organization.

A Rotarian since 1980, Rassin served as RI president in 2018-19, when he advocated for closer partnership between Rotary and Rotaract clubs and presented the measure that broadened the definition of membership in Rotary International to include Rotaract clubs at the 2019 Council on Legislation. He is currently active on the Bahamas Rotary Disaster Relief Committee and is working on relief efforts in the wake of Hurricane Dorian and the COVID-19 pandemic. He also helped found the Haiti National Clean Water, Sanitation, and Hygiene Strategy (HANWASH), a collaborative program to

bring potable water and adequate sanitation to all the citizens of Haiti. In 2018, the government of the Bahamas named him as an Officer of the Order of Distinction.

She has served Rotary as chair of the Peace Major Gifts Initiative and is currently a member of the site selection working group for the new peace center. Q. Why is increasing our ability to adapt one of the priorities of the Action Plan?

NICKI: Everyone, and every organization, is looking to make a greater societal impact. It's an enormous opportunity for Rotary to be a thought leader and a sought-after partner. But if we want to lead in a time of accelerating change, we need to become — and to be seen as — more agile and relevant.

Q. What are the challenges?

NICKI: As an organization, we're very fragmented and hierarchical. We have rules, officers, titles, and committees instead of teams. The more administrative layers you have, the more removed you are from the actual work.

We need to look at leadership as something anyone at any age can own. You don't need 40 years of experience before you can significantly contribute. Remember, Paul Harris was only 36 when he started Rotary.

Q. Where are you seeing opportunities?

NICKI: Before the pandemic, a large percentage of Rotary members didn't really think or see beyond their club. They didn't have a sense of themselves as a global network of changemakers. During the pandemic, people were joining virtual meetings in different districts and countries and seeing for the first time all the things Rotary was doing.

We're capitalizing on this momentum. I worked with a team in Great Britain and Ireland that started a Rotary global hub, an online platform that connects people to clubs but also gives them the opportunity to participate based on causes rather than location. And their involvement can be episodic rather than tied to a weekly meeting at a specific time. It is proving very successful in both attracting new and retaining existing Rotarians. MEET NICKI SCOTT. A change-management consultant and a member of the Rotary Club of The North Cotswolds, England, Scott helped develop our Action Plan as part of Rotary's Strategic Planning Committee. She is the 2022-23 vice president of Rotary International.

I also see Rotary doing more to build on the work of others, to share leadership. In Great Britain and Ireland, we host Volunteer Expo, an event where all kinds of people and organizations can come together and collaborate. We don't have to reinvent the wheel every time.

Q. What structural changes will increase Rotary's ability to adapt?

NICKI: More regional autonomy is key. What might work for one region might not be a cultural fit for another.

We can be much more regionally focused without losing the ideals of a global organization, or losing the power of a global brand. We can achieve harmony and amplify the sound if we all play the same tune instead of a staccato selection of solos.


Q. What makes you most optimistic?

NICKI: Rotary has something powerful to offer. There are a lot of well-meaning organizations out there, but good intentions don't always translate to results. Rotary has the infrastructure and the integrity that people are looking for, and the connections in communities to know what is really needed. We know how to get the job done. We are people of action.
