PH, JAPAN open-heart surgery tie-up

From Friendship Exchange to Vocational Training Team, Rotary fellowship in service has evolved and scaled new heights. Two districts from two countries focus on a special area of vocation or calling that brings forth a full-scale demonstration on how peoples of different countries and cultures work together to fulfill a humanitarian mission.

hrough the Vocational Training Team (VTT) program, Rotary facilitates the delivery of humanitarian services through partnerships among Rotary districts. Our District 3860 has teamed up with District 2760 based in Nagoya, Japan to conduct open heart surgery among patients in Visayas and Mindanao. As VTT chair, I worked directly with the head of our partner district's counterpart team, my esteemed fellow heart surgeon, Dr. Takahiko Aoyama.

This partnership was arranged through the efforts of Past District Governor Rodel Riezl Reyes, and Past Presidents Tetsuo Fukuda of the Rotary Club of Nagoya and Past President Susan Czudai of RC Angeles Balibago (D3790).

Since July 2023, a series of zoom meetings were held with our counterpart team from Japan were done, discussing the need to further enhance and develop our nation's health services for Filipino children afflicted with congenital heart disease. We were gifted by the availability of Professor Shunji Sano, a world-renowned heart surgeon who has done hundreds of heart operations worldwide. He has authored hundreds of research articles and developed several pioneering techniques that have saved countless of lives for decades.

District 2760's VTT visited the Southern Philippines Medical Center and Camp Quentin Merecido Hospital in Davao last July. Prof. Sano also delivered a lecture which was attended by local doctors and medical students. Our joint VTT came up with a plan to provide equipment and undergo further exposures on the latest medical advancements through a Global Grant from The Rotary Foundation accessed by both Districts.

Eight team members traveled to Japan on December 10, 2023 to train on congenital heart surgery. The team was composed of non--Rotarians from different medical fields like nurses, echo technicians, family physicians, heart surgeons and anesthesiologist. They underwent a weeklong training program, attended lectures and mentorship with Dr. Sano on different diagnostic modalities and surgical techniques in three different major heart centers in Japan namely, Nagoya University Hospital, Chukyo Hospital and Aichi Children's Health and Medical Center.

Governor Rozanne 'Twinkle' Gamboa accompanied the D3860 District VTT, and they were welcomed by District Governor Noritake Sakai and officers of our partner District 2760. Fellowship activities were hosted by the different Nagoya-based Rotary Clubs.

Fresh from their training in Japan, the D3860 VTT conducted a two-day heart surgery mission in Cotabato Regional and Medical Center last January 15 and 16, 2024. Working with other heart specialists, the VTT successfully performed 14 major heart surgeries and 9 device closure operations on children-patients from Region 12. Our District VTT will conduct a vascular surgery mission in Tagbilaran, Bohol on January 29-31, 2024. More upcoming VTT surgical and medical missions in our district are in the pipeline.

My personal experience with VTT is profound and awe-inspiring. It has reminded me that each of us can do more for humanity through the vocation that God has given us. The task demands intense focus, concentration and dedication. It is also a fulfilling experience that reminds us of the importance of using our Godgiven talents and resources in serving our needy brethren.



ARE YOU PREPARED TO FACE THE OBESITY EPIDEMIC?



<u>WHO classifications for obesity</u> are the most widely accepted worldwide. Though there are limitations, the <u>BMI score</u> is "the most feasible and widely used criteria to identify and classify patients with overweight or obesity," according to the <u>latest guidelines</u> from the American Society of Metabolic and Bariatric Surgery and International Federation for the Surgery of Obesity and Metabolic Disorders (IFSO) Indications for Metabolic and Bariatric Surgery.

<u>WHO classifies obesity</u> as a BMI of 30-39.9, overweight as a BMI of 25-29.9, and severe obesity as a BMI of \geq 40. Although BMI typically correlates closely with percentage body fat in a curvilinear fashion, some important caveats apply to the <u>interpretation</u>. In mesomorphic (muscular) persons, the BMIs that usually <u>indicate</u> <u>overweight or mild obesity</u> might not be applicable. In contrast, in some persons with sarcopenia (e.g., elderly individuals and persons of Asian descent, mainly from South Asia), a typically normal BMI might conceal underlying excess adiposity <u>characterized by an increased</u> <u>percentage of fat mass and reduced muscle</u> <u>mass</u>, per Hamdy and colleagues.

A sedentary lifestyle in combination with the consumption of unhealthy diets (e.g., a highsugar and refined-carbohydrate diet) is currently considered the leading common cause of the obesity epidemic, per Boutari and colleagues. The data are based on a recent report from the WHO. The same report claims that there is a downward trend of obesity in older adults between the ages of <u>50 and 65 years</u>. Although genetics can play a role in the development of obesity, the WHO did not claim that predisposing factors are the leading causes of the obesity epidemic. Though endocrine and endocrinerelated disorders have been associated with obesity, they are not the main factor contributing to the obesity epidemic.

ARE YOU PREPARED TO FACE THE OBESITY EPIDEMIC?

Visceral fat can negatively affect individuals and has been linked to unfavorable metabolic activity and cardiovascular adverse events. Some studies have measured visceral fat in an attempt to predict the risk for cardiometabolic events and determined that visceral fat can increase such risks. According to Murata and the standard techniques colleagues, for measuring visceral fat are <u>MRI</u> and <u>CT</u>. Less expensive techniques for directly measuring visceral fat include abdominal ultrasonography, dual-energy x-ray absorptiometry, and, to a extent, abdominal bioelectrical lesser impedance.

To promote long-term weight maintenance, the use of approved <u>weight loss medication</u> (over no pharmacologic therapy) is suggested to alleviate comorbidities and increase adherence to behavior changes. <u>According to Tchang and</u> this might improve colleagues, physical functioning and allow for greater physical activity in individuals with a BMI \geq 30 and in individuals with a BMI \geq 27 and at least one associated comorbid medical condition (e.g., hypertension, dyslipidemia, type 2 diabetes, or obstructive sleep apnea). These criteria also apply to the recently Food and Drug Administration-approved medication for chronic weight maintenance, <u>tirzepatide</u>, a glucagonlike peptide-1 receptor, and glucose-dependent insulinotropic polypeptide receptor agonist.

In most cases, the <u>initial management of obesity</u> generally consists of multicomponent lifestyle interventions that include nutrition, physical activity, and behavior changes. Further, the <u>IFSO</u> and World Gastroenterology Organization urge physicians to consider that "all aspects of nonsurgical management must be tailored to each patient, as no one diet, behavior, exercise program, or medication will be accepted by or effective in all patients, and none has been documented as first-line or superior to all others."

Many guidelines suggest focusing on reducing body weight as the initial treatment goal. For example, the <u>European Association for the Study</u> <u>of Obesity</u> recommends that the first treatment goal for patients who present with obesity is to stabilize body weight.


Managing weight as a primary strategy rather than focusing only on the comorbidities associated with obesity, such as <u>obstructive</u> <u>sleep apnea</u>, <u>hypertension</u>, and <u>dyslipidemia</u>, will help decrease the incidence of these complications by proxy.

Rotary International: HOW ROTARACTORS CAN PARTICIPATE IN ROTARY GRANTS: FREQUENTLY ASKED QUESTIONS (January2022)

GENERAL

Q: How can Rotaract clubs be involved in Rotary grants?

A: As of January 2022, districts that apply for Rotary Foundation district grants can include Rotaract club activities in their spending plans. As of July 2022, Rotaract clubs can apply for global grants to support their service work in their own communities or abroad.

Q: What can Rotary clubs and districts do to be ready for Rotaract clubs to participate in Rotary grants?

A: Rotary clubs and districts can:

- Invite Rotaract members to complete a grant management seminar so that their clubs can become qualified to apply for global grants
- Appoint Rotaractors to district committees and subcommittees
- Work with Rotaract clubs on grant-funded projects
- Develop a system to track Rotaract clubs' participation in global grant projects
- Ask Rotaract members to help organize a fundraiser
- Consider changing how district designated funds (DDF) are distributed in order to increase Rotaract involvement
- Invite Rotaract clubs to participate in project fairs
- Work with Rotaract clubs in the district to make sure they have reported their current membership information to Rotary

Q: What can Rotaract clubs do to be ready to get involved in Rotary grants?

A: Rotaract clubs and members can:

- Learn about Rotary grants
- Participate in a grant management seminar and work with district leaders to become qualified to apply for global grants
- Help conduct a community assessment
- Take an active role in implementing a project funded by a district or global grant
- Work with a Rotary club to organize a fundraiser for a grantfunded project
- Participate in public relations and advocacy efforts for a grant-funded project
- Contribute technical, cultural, or academic expertise to a grant-funded project
- Make sure that your club's current membership information has been reported to Rotary

Q: Can Rotaract clubs apply for disaster response grants?

A: No, disaster response grants are awarded to districts. However, a district may choose to distribute grant funds to a Rotaract club tocarry out disaster response activities.

Q: Can Rotaract clubs apply for Programs of Scale grants?

A: Yes, Rotaract clubs may apply for Programs of Scale grants.Learn more about Programs of Scale.

Q: Can Rotaract members benefit from grant-funded training?

A:Yes, Rotaractors can take part in grant-funded training such as a vocational training team. In order to comply with Rotary's conflict of interest policy, the grant that benefits a Rotaract member may not be sponsored by that person's Rotaract club.

Q: Can Rotaractors receive a district or global grant scholarship?

A: Yes. The Rotary Foundation Trustees have agreed that Rotaractors can benefit from scholarships funded by a district or global grant. In order to comply with Rotary's conflict of interest policy,the grant that benefits a Rotaract member may not be sponsored by that person's Rotaract club.

Q: Can Rotaract members serve as vocational training team members?

A: Yes. Rotaractors can either receive or provide training as part of a vocational training team. Rotaract members who want to serve on a team that will provide training through a global grant need to have at least two years of work experience in the relevant area of focus.

Q: Will Foundation giving reports on My Rotary include donations made by members of Rotaract?

A: Yes, giving reports will include contributions made by Rotaractors, which will facilitate donor recognition and the tracking of club giving totals. As reports become available on My Rotary, individual Rotaract and Rotary members will be able to view the report on their own giving, and current club, district, and regional officers will be able to view the reports for their respective Rotaract and Rotary members. Reports with giving data may only be viewed for official business purposes, in accordance with Rotary's privacy policy.

GLOBAL GRANTS

Q: Does a Rotaract club need prior experience with global grants to apply for a global grant?

A: Yes. To be eligible to sponsor a global grant, a Rotaract club needs to have previously worked with a Rotary club or district on a global grant-funded project.

Q: What types of activities qualify as prior experience for Rotaract clubs that want to apply for global grants?

A: These activities qualify as prior experience with global grants:

- Conducting a community assessment in preparation for a global grant
- Raising funds for a global grant
- Participating in public relations efforts for a global grantfunded project
- Actively participating in implementing a global grant-funded project
- Providing technical support to a global grant-funded project
- Helping to measure and evaluate a global grant-funded project

Q: How will a Rotaract club's participation in global grants be monitored to ensure that a club applying for a grant has the necessary prior experience?

A: The district will track a Rotaract club's participation in global grants. When district Rotary Foundation chairs authorize an application, they will confirm that the club meets the participation requirement. The Rotary Foundation won't manage this information.

Q: Can two Rotaract clubs sponsor a global grant, with one as the host sponsor and the other as the international sponsor?

A: No. If one sponsor is a Rotaract club, the other needs to be a Rotary club or district.

Q: When a Rotaract club applies for a global grant, who authorizes the application?

A: The Rotaract club president will authorize the application on behalf of the club.

Q: Do Rotaract clubs have access to the Grant Center to apply for a global grant?

A: As of July 2022, Rotaract clubs can apply for a global grant using the Grant Center. To plan and prepare a draft application in advance, clubs can use the Global Grant Application Template.

QUALIFICATION

Q: Do Rotaract clubs need to be qualified to receive district grant funds?

A: The Rotary Foundation doesn't require Rotaract clubs to be qualified before receiving district grant funds.

However, districts may choose to make this a requirement for both Rotary and Rotaract clubs.

Q: Do Rotaract clubs need to be qualified to participate in global grants?

A: Yes, Rotaract clubs need to be qualified to participate in global grants.

Q: How can Rotaract clubs become qualified?

A: Rotaract clubs should contact district leaders to arrange for members to participate in the district's grant management seminar or online grant management seminar in the Learning Center. In addition, the district leaders can provide the club MOU for review and authorization.

Q: Who keeps track of Rotaract club qualification? Do Rotaract clubs need to prove that they are qualified when they apply for global grants?

A: The district is responsible for tracking a Rotaract club's qualification. District leaders will confirm as part of the application in the Grant Center that the Rotaract club is qualified.

Q: How can Rotaract clubs learn more about becoming qualified?

A: Members can read more about qualification on My Rotary. They can also send questions to stewardshipdepartment@rotary.org.

DISTRICT LEADERSHIP

Q: Are districts required to appoint a Rotaractor to a subcommittee role?

A: No, but we encourage it. The only district roles that Rotaractors aren't eligible for are governor, assistant governor, and district Rotaract chair.

Q: Are districts required to include a Rotaractor on their district grants committee?

A: No, but we recommend it. Rotaractors are an important voice on district committees.

Chartered on February 23, 1993, as an all-women service club, by then RI President Robert R. Batch. The charter year was one great celebration as the whole Rotary world was then celebrating the 88th Foundation Anniversary of the Rotary International. RCDD became the 29,258th Rotary club worldwide and the 79th club in District 3860.

On its 26th year in RY 2018-2019, RCDD marked another historical milestone when it inducted two distinguished gentlemen to the club membership, Paulino B. Ko, a successful businessman, and Archie Francisco F. Gamboa, a high-ranking Police General, who then became the Chief of the Philippine National Police, and RCDD's first male club President. This turned RCDD into a mixed club from an all- women club to manifest Diversity, Equity and Inclusiveness (DEI).

This RY 2023-2024 RCDD starts its 31st year of service and fellow- ship with 37 men and women of various professions, leaders of their own fields of specialization. RCDD's Rooster of Membership is a balance of the senior-aged group, middle-aged and the young generation. This year marks another milestone as its very own Past President Rozanne "Twinkle" C. Gamboa is installed as District Governor, the second from the club. The first was the club's Charter President, Evelyn "Len" A. Magno.
